

<Purpose of use and other details of personal information>

Personal information acquired or held by EA Pharma Co., Ltd. (hereinafter referred to as "EA Pharma") will be used for the following purposes:

1. Physicians, pharmacists, nurses, and other medical professionals

- (1) Provision and collection of information on proper use of pharmaceuticals
- (2) Provision and collection of information on the quality, safety, and efficacy of pharmaceuticals
- (3) Surveys and research in the fields of medicine and pharmacy
- (4) Provision, collection, and investigation of healthcare and medical science information
- (5) Membership authentication and membership management of internet sites for medical professionals
- (6) Provision of services, distribution of advertisements, and so forth through analysis of information including website browsing history
- (7) Requests and implementation of clinical trials, post-marketing surveillance, and so forth
- (8) Notification and reporting to the government authorities

2. Public relations and users of Pharmaceutical Products Consultation Desk or EA Pharma's other support desks

- (1) Examination and investigation of the contents of consultations, contacts, and so forth, and response to the same
- (2) Contacting and providing information to marketing authorization holders of pharmaceutical products, manufacturers, distributors, medical professionals, and so forth
- (3) Notification and reporting to the government authorities

3. Officers and employees of corporations or organizations with which EA Pharma has a business relationship or industry activity relationship

- (1) Review, investigation, and response related to transactions and industry activities
- (2) Contacts and information sharing related to transactions and industry activities
- (3) Notification and reporting, as well as other necessary administrative procedures, related to business transactions and activities in the industry
- (4) Building smooth relationships necessary to achieve the purpose of use

4. Applicants for jobs at EA Pharma

- (1) Communication related to recruitment examinations, employment or rejection, and so forth

5. Directors, executive officers, auditors, and employees of EA Pharma

- (1) Time and attendance management, schedule management, payment of salaries and allowances, human resources, general affairs, evaluation, skill development, welfare benefits, health and safety, and so forth
- (2) Contacting and providing information to the health insurance association, stock holding association, life insurance companies and non-life insurance companies (limited to those companies brokered by EA Pharma), EA Pharma's consolidated companies and equity-method affiliates listed in the securities reports of EA Pharma and Eisai Co., Ltd., as well as Ajinomoto Co., Inc. and their domestic affiliates
- (3) Notification and reporting to the government authorities

6. Patients (including participants in clinical trials, post-marketing surveillance, and other clinical studies)

- (1) Communication and response to compensation and indemnification for health damage
- (2) Notification and reporting to the government authorities and member organizations
- (3) Evaluation and analysis for research and development related to pharmaceuticals, diagnostic agents, medical devices, and so forth
- (4) Evaluation and analysis of usage and attitude, user needs, marketability, user satisfaction, and so forth related to pharmaceuticals, diagnostic agents, medical devices, and so forth
- (5) Other purposes of use for which consent has been obtained from patients when participating in clinical trials, post-marketing surveillance, or other clinical studies
